It is provided in accordance with the recommendations of the International Association of Schools of Social Work (IASSW), the International Federation of Social Workers (IFSW), the directives of the European Union and in accordance with the professional and value direction of the St Elizabeth University of Health and Social Sciences in Bratislava.

The aim of the third-level education in the field of social work, study program mission and development work is for graduates to acquire such professional knowledge, practical skills and competencies as to be able to improve the social functioning of clients, to be able to implement community planning, actively influence social policy and be able to perform managerial activities. The graduate has skills to use the scientific methods of research in social work that he is able to implement a practice based on scientific knowledge and critically reflect on it. During their studies, graduates will acquire:

With the final work and its defense, the student demonstrates the ability to:

- work independently in the field of mission, charity and development,
- independently acquire theoretical knowledge and creatively solve problems in the field of missionary, charitable and development activities,
- independently address the tasks of missionary, charitable and development activities, its management, research, educational process and ethics,
- independently, creatively and comprehensively solve and explain the chosen problem, which the student will analyze and research in the work.
- to form an overview of theoretical and application problems in the field of study social work, with a focus on missionary, charitable and developmental work.
- apply methods and techniques of empirical cognition with respect to the chosen issue of work.

The final work has a theoretical and empirical part, which are closely related to each other, or the whole is written in IMRAD format.

The PhD student submits the completed final thesis within the prescribed deadline. After receiving the proposal of the chairman of the specialization commission, the rector appoints the defense commission and its chairman, including the opponents of the dissertation. The Rector appoints opponents on the basis of a proposal by the chairman of the specialization commission, which may be based on the proposal of the supervisor (tutor). Opponents are selected from among experts in the field or of the doctoral study specialization and may not be employees of the same department or institute.

At least one opponent is from a different workplace than St Elizabeth University. At least one opponent must hold a scientific-pedagogical title of professor, or be a holder of the scientific degree of DrSc., or be a researcher with the awarded degree I. Other opponents may be prominent experts with a PhD.

The chairman of the defense committee no later than 60 days after receiving the materials on the defense of the dissertation will propose to the Rector the time and place of the defense of the dissertation. Based on the proposal, the Rector determines the time and place of the dissertation defense. The relevant department of the Rectorate of the University of ZSP sv. Alžbety will ensure the publication of the dissertation defense notice. Anyone who is interested in the researched issue and the defense of the dissertation may submit their statement to the chairman of the defense commission no later than one week before the defense, or they may present their remarks orally during the defense. During the defense of the dissertation, the PhD student takes a position on such statements or remarks. The dissertation defense itself consists of three parts:

- 1. the PhD student presents the issues and the current level of knowledge, methodology, results, comparisons and research recommendations.
- 2. the opinion of the opponents on the presented dissertation, presentation of questions and remarks on the work and on the given scientific issues,
- 3. the doctoral student's statement on the asked questions and a scientific discussion chaired by the chairman of the commission.

In other relevant situations, the procedure is in accordance with the document "Creation, application and evaluation of the internal quality system of St Elizabeth University", as well as the Study Regulations and the Rector's Regulations.

8. Spatial, material, and technical provision of the study programme and support

a) List and characteristics of the study programme classrooms and their technical equipment with the assignment to learning outcomes and courses (laboratories, design and art studios, studios, workshops, interpreting booths, clinics, priest seminaries, science and technology parks, technology incubators, school enterprises, practice centers, training schools, classroom-training facilities, sports halls, swimming pools, sports grounds).

St Elizabeth University has three teaching workplaces at the central workplace in Bratislava, namely: Nám. 1. mája 1, Nám. Slobody 3 and Polianky Pod brehmi 4/A.

Nám. 1. mája: the main muilding where auditorium hall is located with a capacity of 120 seats, which has a variety of uses. In addition to the lecture room, it also serves as a representation room for graduations and conferences. It is equipped with a PC, data projector, flipchart and sound equipment, which is used to sound festive occasions.

On the ground floor, first and second floor there are a total of 6 lecture rooms, 4 with a capacity of 80 seats and 2 with a capacity of 30 seats. Each of them is equipped with a PC, data projector and overhead projector.

Lecture rooms are used mainly for the study field of social work, external form of study, but they are also used in parallel by the study fields of public health, nursing according to the prepared schedule.

In addition, the building has a library, rooms for teachers, laboratories for the departments of LMV, Public Health and Nursing. Accessibility is ensured by the Wimec v65 lifting platform (Nám. 1. mája).

Nám. Slobody 3: in this building, there are three lecture rooms with a capacity of 30 seats, which serve mainly for the study field of social work full-time study. These rooms are also used for the subject of Socio-psychological training. Each room has a PC, data projector, flipchart and free internet access for all students.

Polianky Pod brehmi 4/A: this building has auditorium hall with a capacity of 100 seats on the ground floor, which provides multifunctional use. Upstairs there are lecture rooms with a capacity of 20, 40 and 35 seats and laboratories for the medical department of dental technology, there is a demonstration room for nursing where an interactive whiteboard is. Each room has a PC, data projector and sound system. On the second floor is the Department of Missiology with a multifunctional meeting room and library.

Classrooms

Specialized teaching is carried out in the classrooms of the University in Bratislava. The school has a fully equipped multimedia room, which contains an interactive digital board with above-standard sound equipment, especially suitable for playing multimedia files. The school has a network license of the SPSS program (statistical software for social phenomena) for 25 computers that can be used in parallel, as well as the Atlas - TI program for qualitative research. Another specialized classroom is equipped with 15 computers containing 30 pieces of standard software - Windows XP, Microsoft Office suite with programs (Microsoft Word, Microsoft Excel, Microsoft Outlook, Microsoft Power Point) - as well as means of communication, especially resources based on the use of computer networks, multimedia resources.

Material and technical support necessary for teaching the study program.

Classrooms are set up with chairs with a folding desk designed for writing. Ceramic boards are installed in the classrooms, and an interactive whiteboard is in the auditorium 102. Laptops and projection technology, data projector, overhead projector and sound technology are available for the lecture activities according to the requirements of the teachers.

For the purposes of social-psychological training, the university also uses the Educational and Development Center Bl. Mother Teresa in Dolná Krupa. There are three training rooms, each with a capacity of 60 people with the following technical equipment: TV, PC, data projector, flipchart board, internet access. For multi-day training, it also has 6 rooms available for accommodation with a capacity of 20 seats.

b) Characteristics of the study programme information management (access to study literature according to Course information sheets, access to information databases and other information sources, information technologies, etc.).

Department of Missiology within the St. John Paul II Institute of Mission Work and Tropical Health which carries out the PhD study program Mission and Development Work, is located in Bratislava Polianky, Pod brehmi 4/A. The department has own library with journals and book titles in the field of social work, missiology, charity and development work. There are also study rooms equipped by computers with internet access in the building in Polianky. The library contains book titles and textbooks in Slovak, Czech, English, Russian and other languages. In addition to the departmental library, students also have at their disposal the central library of the university, which is located in Nám. 1. mája. The central library is a comprehensive automated information and library system. It is connected to the Internet and is equipped with information networks. There is a rental of monographs, textbooks and electronic documents, as well as qualification theses (diploma, dissertation, rigorous, habilitation). A multimedia-equipped study room with computers and a data projector is available. Library services are focused on:

- absentee lending
- loan attendance
- interlibrary
- consulting, in the use of information technology
- publishing, services with ISBN security when publishing publications within the whole school publishing house
- reprographic services for library users,
- sale of professional literature by university teachers of St Elizabeth University
- entries in the central registers.

Several teaching texts on the subjects of the study program come directly from the publishing activities of the university itself. Current information about the library is available on the home page of the library continuously updated at http://www.vssvalzbety.sk/kniznica.

St. John Paul II Institute of Missionary Work and Tropical Health publishes the academic journal *Acta missiologica* indexed in the worldwide scientific database Web of Science and in the European database Copernicus. The journal publishes the results of the best research projects carried out by students of the study program Missionary and Charity Work as well as the study program Mission and Development Work at the Department of Missiology. Domestic and foreign experts in the field of mission, charity, humanitarian and development work also contribute to the journal.

Feedback from graduates is obtained only sporadically during personal meetings or telephone conversations. We have positive feedback, for example, from the graduate PhDr. Zuzana Kotlárovej, PhD. (graduated in 2020), which operates in OZ Roma Center Ternipen, Snina. She is an expert in the creation of the strategy of the action plan of the national project "Snina - a city of equal opportunities for all" within the program "Local development, poverty reduction and Roma inclusion".
